Terms of Agreement

Please read carefully before signing

Outside food & beverages are not allowed in our facility. Birthday cake and ice cream are the only exceptions. This is not only Hooper Bowling Center's policy, but the Department of the Army MWR policy.

You can Bring:

- Gifts
- Cakes
- Ice cream
- Tablecloths
- Decorations, but NO glitter, confetti, piñatas, or silly string. NO tape on walls.
- Balloons are ONLY allowed in the Cosmic Room area & must be tied down.
- Candles are okay just don't forget a lighter.

* You are reserving lanes for the specified period of time indicated on the front of this contract, this includes set up. While we make every attempt to schedule enough time between events to allow for such preparations, this is not a guarantee. If you believe you will need additional time we will be happy to increase your reservation time at an additional cost based on availability. Please keep this in mind and plan accordingly.

* Children must be supervised by an adult at all times. There is no running, rough housing, or horseplay allowed in the bowling center. We understand children get excited, however if we are forced to correct children too many times or if their behavior becomes disruptive to other guests, they will be asked to leave along with their supervising adult; no refunds will be given. This is for the safety of you and other patrons.

* If you wish to order food for your party, we ask that you provide at least 72 hours advance notice to ensure availability.

* Anyone consuming alcohol must present a valid ID and wear an armband for the duration of their visit at Hooper. There are no exceptions to this rule. Failure to comply will result in appropriate action being taken.

* There is no smoking inside our facility. If you wish to smoke, you may use one of our outdoor smoking areas, but you must be at least 50 feet away from any entrance.

Most importantly, remember that everyone is here to have FUN! Please be courteous and considerate to other guests that may be using the facility and encourage your guests to do the same. If at any time you observe or encounter a problem, please alert the front desk.

By signing below, you are agreeing to all of the terms listed above. There will be no exceptions. You will be given a copy of this contract and Hooper Bowling Center will keep a copy with your party information. Understand that, unless you have booked the entire Cosmic Room or bowling center, there may be other patrons bowling on adjacent lanes. The minimum \$25 deposit is required at the time of signature. If you must cancel your party, please do so at least 24 hours in advance. Deposit is forfeited if cancellation is within 24 hours of your reservation. Payment to be made at start of function.
