SUBJECT: Off-Limits Establishments

1. These establishments/areas are declared off-limits to military personnel. If in any case the name or owner has changed, the address shall remain off-limits.

a. Establishments

(4) Nashville, Tennessee

(a) Military Housing Department and any business operated by Mr. Thomas E. Bowen, wherever it may be located.

b. Areas

(1) All bodies and streams of water on Fort Campbell are off-limits for unauthorized water sports and activities.

(2) All rock quarries, both active and abandoned, within Kentucky and Tennessee are off-limits for all purposes. The only exceptions to this prohibition are:

(a) The Cerulean Spring Quarry, Cadiz, Kentucky, may be used for scuba diving only during operating hours.

(b) Martha's Quarry, located east of Lebanon, Tennessee may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.

(c) Cowan Quarry, located south of Cowan, Tennessee, and may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.

(d) Hopkinsville Diving Quarry, located off exit 9, adjacent Pennyrile Parkway, and 680. Non-diving recreational use is not permitted

2. Military personnel observed in off limits establishments are in violation of a lawful general order and are subject to disciplinary action for violation of Article 92, UCMJ.
3. This off-limits list supersedes the Off-Limits Establishments memorandum dated September 24th, 2024.
4. Off-Limits Establishments are prohibited from advertising on the Installation.
